Terry Sadler reported that Speedwatch sessions were affected by lockdowns and restrictions during the last year. Sessions restarted at the beginning of May 2021.

• Ickleton Society

Rachel Radford reported that a summer walk was organised in June 2019 with a focus on biodiversity. An archaeological dig at Abbey Farm was started in the summer of 2019 and a socially distanced dig was continued in the summer of 2020. The dig will continue this summer and they are hopeful of finding medieval artifacts. An exhibition was held at the Church late 2020. The New Years Day walk went ahead in 2020 but was unable to go ahead in 2021. The Society held a wine tasting session before the covid pandemic and hope to hold another when restrictions are lifted. Andrew Shepherd is producing a time line of events in Ickleton, which he is overlapping with national events. Parishioners continue to share photos with the Society and upload photos to the Facebook page. The Annual General Meeting will be held on the 21st of May 2021. Rachel thanked the Society Committee and everyone who supports them.

priestly ministry to a benefice. He stated that it has proved to be a cost effective and successful way of finding Priests.

- **Froglets**

Email received and read by the Parish Councillor Chair. Not much to report on the last year.

They are hoping to reopen on the 17th May 2021 with certain conditions. They need to form a new committee so need to gather old members and find new ones. They will have to do a thorough clean and put in place some covid safety measures.

- **Ickleton Football Club**

Chair Steve Jenkins reported that the last two seasons have been cut short due to Covid-19. The 2020 season only ran from mid-September to early December. The team has struggled to keep numbers up for the last few seasons as players are unable to commit to regular Sunday football. Some older players have left the team and some young men in the village are away at university during term time. An elector asked how many regular and reliable players are on the team and Steve stated around 6. An elector asked how many are needed and Steve stated that 12-14 players and substitutes. An elector asked why there is a lack of commitment and Steve stated he thinks it's primarily because teams play during the week and players do not want to commit to a Sunday. The Parish Council Chair asked if the Parish Council could help and Steve stated that the facilities are good and it is just difficult to find committed players.

- **Age UK Community Warden**

Sarah Thomson reported that Age UK have been delivering Warden Schemes for 27 years. Funding has meant that 6 new schemes have started around Cambridge. A new Warden Scheme for Ickleton and surrounding parishes was started in 2020. A second warden post will be filled when the scheme grows. Currently there are 9 people in the scheme, 1 of which is from Ickleton. The scheme has been difficult to promote during Covid-19. All wardens have received both their vaccines. The scheme is currently advertised in Icene and the Parish Council website. The Parish Clerk will put posters up on noticeboards and deliver posters to residents of Icknield Close in particular again.

6/21 **Open Forum**

- An elector introduced himself and explained that he had recently moved into the parish. He was welcomed by the Parish Council Chair.
- An elector who has been involved with the Openreach fibre broadband funded by the Government Rural Gigabit Voucher Scheme stated that letters from Openreach are still to be received by parishioners. The Parish Council Chair thanked him and Martin Woodhead in particular for their contribution to the effort.

Appendix A – Report from the Chair of the Parish Council

It is 2 years since the last Chairman's Report. The covid 19 pandemic resulted in the cancellation of the 2020 APM, and the suspension of face to face Parish Council meetings for 12 months from last April. We have continued with Parish Council business using Zoom, but I think we will all be pleased to return to the Village Hall in June for a "normal" meeting.

Finance - The year end balance is £38,854.66 less than in 2019. There has been an increase in the precept to £25,500. Copies of the draft financial statements are available on request from the Clerk, and will be published on the Parish Council website.

Leanne Smith, our Parish Clerk, joined us in June 2019, and has proved to be a great asset to the Parish Council. One of Leanne's first initiatives was the development of a dedicated Parish Council website which I hope has proved useful and informative. We were pleased to welcome Edmund Heaney as Councillor, but Katherine Denman -Johnson stepped down, so there is a vacancy. If anyone would like to apply, please contact the Clerk in the first instance.

2020 was a strange year, with repeated lockdowns and restrictions affecting all of us to some degree. Despite this, Parish Council were able to continue with a programme of works to improve and repair infrastructure in the village. The bus shelters have been repaired and painted and notice boards installed. Benches and railings on the recreation ground and in other locations have been cleaned, repaired, and painted as appropriate. Regular maintenance of the playground has continued, and new grit bins and dog bins installed at Stackyards and Coploe Road.

Biodiversity, or lack of it, was a hot topic in 2020. Parish Council are keen to do their bit to improve wildlife habitats and increase biodiversity in the village. The first step has been to plant new hedging around the allotments and along Coploe Road. Our thanks to Simon for sourcing the plants from the Woodland Trust, and to Dominic for preparing the ground and planting the hedge. It looks really great, and should help to provide food for pollinators and birds, as well as sheltering the allotments from the wind.

In August 2019, Hugh Molloy organised a work party to inspect and clean the Cemetery Chapel, a lovely Arts and Crafts building which is seldom open to the public. We had hoped open the Chapel for events during the year, but of course, these plans were put on hold. However, broken roof and ridge tiles have been replaced, and the gully's cleared of moss. All of the windows were damaged to some degree, and urgent work to repair the worst was done in January 2020. The remaining windows have been removed, repaired and replaced and this work should be completed soon. Parish Council agreed that the expenditure was justified to keep the building watertight and in good condition.

Through the Local Highways Initiative, the Frogge Street traffic calming build out was completed, and the Butcher's Hill pedestrian safety measures installed. I thank Simon and Terry for their input with this. We remain frustrated at the lack of response from Highways to reports of potholes and poor road surface conditions in the village. Councillor Peter MacDonald has been helpful in getting some of the repairs done, but it is still a slow process.

Due to covid restrictions, the Speedwatch team were unable to do their regular monitoring, but the vehicle activated speed sign was in use and certainly seems to be effective in slowing traffic down. Speedwatch will soon be back in action, and I thank them in advance for their efforts. One positive result of the pandemic has been the reduction in rat running through Ickleton and surrounding villages. Unfortunately, this will increase markedly as restrictions lift and people return to their places of work. Parish Council is not aware of any major infrastructure improvement proposals, but the conclusions of the A505 study may be of some influence in future planning decisions.

There was little progress in 2020 with the major developments likely to impact on Ickleton and the surrounding area. Although NUGC and Smithson Hill have gone away for the moment, the Wellcome expansion already has approval, and will begin at some stage. A worrying concern is the proposed Thakeham development, because the developers appear determined to bypass the local plan procedures and take their proposals direct to Government.

In my last report, Ickleton had been selected for a trial looking at converting some streetlights to LED. The trial has been very successful, and has saved the village over £500 per year in energy bills. Engagement with CCC about poor lighting and pedestrian safety in Icknield Close, resulted in the installation of a solar powered street lamp for the parking area, and solar pavement lights. We hope that residents approve.

During the last year, as many people have been working from home, the issue of slow and variable broadband speeds in the village has been brought into focus. The Rural Gigabit voucher scheme is looking promising, and I thank Martin Woodhead for canvassing the village and moving this forward. We are hopeful that, if sufficient numbers respond to the next consultation, Openreach will proceed with the project.

I am grateful to everyone from the village who continues to give their time to keep Ickleton running smoothly. The Village Hall management committee, John Williams and Hilary Rule for editing and distributing the Icene, the Speedwatch team, Glynis Hammond for Neighbourhood Watch, David Lilly for checking the cemetery and churchyard, Gerry Birch for looking after Coploe Pit, Elaine Statham for welcoming new residents, Claire Driver for the food bank, and many others who litter pick on their daily walks, and generally keep an eye on things. Special thanks are due to Charles Frankau, Dominic Pallett and Ickleton Cricket Club for their maintenance of the recreation ground.

I thank all my fellow councillors for their assistance and support during the last two years. We look forward to a return to normality in the coming months.

Budget Headline

- For 2021-22, Cambridgeshire is set to receive £645m of funding*, excluding grants retained by its schools. But its total expected spending 2021-22 - despite finding savings and additional income of £4m, will be £655m - leaving a £9.612m gap.

We enjoyed an amazing crop of most things especially soft fruit and black tipi beans!

The site is full, I we warmly welcomed the 'class of 2020' who have certainly excelled and have been a massive shot in the arm to the entire site. We have thanked all plot holders who have made the entire site look so tidy this year, we can all be proud of the site now. We had a waiting list with no empty plots, with the support of IPC, who generously gave us a grant of £500.00 we have been able to provide four new plots, which are completed, three have tenants, and we have one ready to go, for the next applicant, Myself and the committee wish to express our sincere thanks to IPC, for your generous support. The forming of these plots became a real community project; A truly Herculean effort which saw some of our plot holders willingly give up their Sunday mornings for a month.

Fund raising efforts included a quiz evening made us £308.00, Plant and cake sale in May, raised £134.02.

I believe our finest hour of 2020 was the Allotment show, we raised £584.56 and we were able to donate £300.00 to Arthur Rank Hospice, more importantly everyone had the best day out in the sunshine, we have a date for this year event, where we plan to build upon last year's success. More importantly we want this to be a real village event.

As we look to 2021, its more of the same, we must to keep fund raising for site improvements, we have a growing list of maintenance tasks, that our becoming more urgent, these can't be paid for by the plot rents hence our need to raise funds to meet these costs.

Appendix E – Report from St Mary Magdalene’s Church

Patrick Bloomfield, Churchwarden

New Priest

Following our prolonged interregnum, Lydia Smith takes office as our new our priest in charge in July 2021. Lydia’s role is a House for Duty, which is three days a week plus Sunday. She trained in Saffron Walden and currently lives near Colchester, so knows the area already.

Hinkledux

We continue to share our priest with the neighbouring benefices of Hinxton and Duxford. We recently appointed a part time administrator to work across the three benefices and support Lydia.

Finances

Despite lockdown challenges, we achieved a positive financial out-turn in 2020/21, due the lower cost of a House for Duty priest and some very kind donations and legacies.

Recent years have been financially challenging. Despite enormous fundraising, we needed a loan from the Diocese to balance the books. Moving to a House for Duty priest has put us on a sustainable financial footing. Once we have repaid our loan and repaired reserves, we hope some of our fundraising can support local good causes.

Services

Through the year the church has been open for private worship and restricted physical services, including outside services on some festival occasions. Weekly Zoom services have helped sustain morale and brought the three Hinkledux congregations together.

Regular physical services have now recommenced, with covid precautions. We are reflecting on what we’ve learned through the pandemic and the nature of services which will best suit the Ickleton and Hinkledux communities going forwards.

Buildings

The church’s quinquennial inspection was due last year and should go ahead this year. Significant planning is going into the restoration of our historic wall paintings, which will be a major event.

Fete and events

We don’t think a traditional fete will be possible in the circumstances, but we are planning to hold alternative events with more manageable risks.

School

Working with Duxford School has been particularly challenging due to covid. We’re optimistic this will resume a more normal pattern in 2021.

Youth

We appointed a new Youth Worker in 2020, continuing the good work through the Youth Inc programme. This too has been online and we hope physical meetings will begin again soon. A Youth Council was formed in 2020 and they helped us select our new priest.

PCC

Several exceedingly long-standing PCC members are retiring from the PCC and new members have come on in their place. Some more new (i.e. younger) members will be needed in next year or so.

Appendix F – Report from Ickleton Cricket Club

The 2020 season was going to be packed full of cricket and events building on the success from previous years. Unfortunately for all of us, things did not quite work out as planned.

With the support of the Parish Council and The Village Hall Committee we were able to get out and play when restrictions lifted and enjoyed 15 fixtures in a truncated season, but sadly we were unable to offer cricket to our youngest members.

Of the 15 games played we had over 36 different players from the village and local vicinity with ages from 14 to seventy-something! And new players continue to join the club. We won more than we lost and considering the obstacles faced this was a terrific outcome.

Our 10th season is now underway and it promises to be somewhat back to normal with Saturday league fixtures for our 1st XI and 2nd XI.

The midweek season will also resume with matches on Wednesday evenings for both teams.

Most importantly the youth cricket sessions return on Thursday evenings, developing the next generation of Ickleton cricketers.

We'd like to express our sincere thanks to the Parish Council for your continued support, particularly in what has been very difficult circumstances for everyone.

Appendix G – Report from Neighbourhood Watch

Neighbourhood Watch is about local people working together to create safer places to live and where crime and anti-social behaviour are less likely to happen. There is no set Neighbourhood Watch programme - each scheme is run by its community. They are generally led by a volunteer co-ordinator from the local community who takes on the role of linking the community to the police. Neighbourhood watch is a great way to keep an eye on crime in your neighbourhood. It will alert you to any unauthorised activity. It can also help to catch criminals as they may change their ways when they know that they are being watched. The criminal will think twice before trying to break into your neighbourhood and this can stop serious crime from happening.

Whilst, we know that crime in Ickleton and the surrounding area is low, it is important for all of us to be vigilant and report suspicious behaviour.

Scams: With fraud accounting for more than half of the UK's reported crime, it's time for us all to take a stand. Scams come in many forms; uninvited contact is received by email, letter, telephone or in person. The most common scams include fake lotteries, deceptive prize draws, computer and romance scams. Postal, telephone and doorstep scams are often targeted specifically at disadvantaged consumers or those experiencing a period of vulnerability. I want to take this opportunity to highlight a couple of examples of this growing crime.

Victim gets a phone call claiming to be from the Post Office. Scammer asks the individual for £2.99 for an outstanding delivery charge. They are then asked to log on to a web site to settle the matter. On the site they are asked for their bank details. The bank account is emptied shortly after.

Victim receives an email claiming to be from Hermes asking for £2.95 to enable a parcel to be delivered. There is an embedded link within the email which when clicked on asks for bank details. The bank account is emptied shortly after.

Small amounts of money are asked for but unfortunately this is the pathway into your personal bank details and available funds. Never, ever, give bank details unless you are certain it is going to a reputable organisation.

This is the latest campaign from Cambridge Police: PROTECT YOUR CAR CAMPAIGN

Due to Covid-19 and repeated lockdowns, people haven't been using their cars as much as they used to. However, car crime remains a pressing problem in the UK – alarmingly, one car is stolen every ten minutes. The latest figures from the Police National Computer indicate car crime decreased during Covid-19 restrictions but with the expectation of social restrictions soon easing we could see a surge in car crime. Neighbourhood Watch are launching a new campaign on the 31st March to encourage everyone to keep their car's safety top of mind.

John Hayward-Cripps, CEO of Neighbourhood Watch Network, says "Most car crimes happen because cars are left unlocked. There is a misconception that some cars are auto-locking and lock themselves if left unattended after a period of time. This isn't always correct. Another misconception is that your car is too old and no one will bother stealing it. This is also incorrect – both new and old cars are at risk.

The thumb-stopping social campaign launching on the 31st March will provide car users with three quick steps to increase protection of their vehicle and direct them to our website www.ourwatch.org.uk to find out more. The key messages of the campaign are:

- Leave your car locked

A simple mistake that can prove calamitous: 44% of cars are broken into via an unlocked door.

- Leave your car well-lit

80% of car crime occurs during the evening or at night. Parking near street lamps or in a busy area can deter thieves.

- Leave your car empty (or with no items on show)

Owners often forget that personal belongings within the car are at as much risk of being stolen as the car itself.

Car thieves are opportunists. Leaving items on a car seat or forgetting to lock your car can act as an invitation for crime. We want to instil the habit of double-checking where and how you've parked with our three simple steps: leave it locked, lit and empty.
