181/19-20 To approve minutes of meeting held on 15th January 2020

It was **resolved** that the minutes of the meeting held on 15th January 2020 are approved and signed by the Chair.

182/19-20 Matters Arising

- i. The Clerk informed the Council that internet security has been sourced from Citadel Solutions Ltd at a cheaper price than directly with the internet security company as approved at the meeting on 15/1/2020. The approval of payment to Citadel Solutions Ltd will be discussed in agenda item 194/19-20 i.

183/19-20 Councillor vacancies

i. Notice to fill vacancy

Cllr Paul Rose stepped down from his position as a Parish Councillor on 15/1/2020 and notice was given pursuant to Section 87(2) of the Local Government Act 1972. The Parish Council have been notified by South Cambs District council that the vacancy can be filled by co-option. ACTION – Clerk to advertise the vacancy in Icene, the village website and on the village notice board.

ii. Filling vacancy by co-option

Edmund Heaney was nominated by Cllr Pavelin to fill the existing vacancy. He introduced himself to the Council. Cllr Wombwell proposed that he was co-opted as a Parish Councillor and all other Councillors voted to co-opt him.

184/19-20 Recreation ground/play area

i. Parking at the village hall/recreation ground

There have been a number of occasions recently where parking at the Village Hall has been insufficient due to several events being held at the same time and the number of attendees. Therefore the Parish Council considered whether the recreation ground could be utilised on such occasions to accommodate extra parking. David Mathias spoke on behalf of the cricket club and the Councillors shared their views. It was decided that consideration would be given on a case by case basis. Cllr Gibson to pass this information on to the Village Hall Committee.

185/19-20 Traffic/Highways Issues

i. Speedwatch – update and correspondence

Poor weather in recent weeks has had an adverse effect on Speedwatch sessions. Approximately 260 vehicles have been reported for speeding to the Police so far this year. Volunteers have come forward to help with the data capture of the Moveable Vehicle Activated Sign.

Correspondence was received from a parishioner acknowledging the work of the Speedwatch Team and requesting recognition by the Parish Council. The Council will give thanks to the Speedwatch Team at the Annual Parish Meeting and Cllr Sadler will pass on the acknowledgment to the Team.

ii. Temporary Traffic Regulation Order - Frogge Street

An application was made to close Frogge Street in both lanes from 16/3/2020 until 20/3/2020 for gas service works to be carried out. The Parish Council opposed the road closure on the grounds that it is a bus route and it would impact negatively on the two village businesses (shop and pub). A

more reasonable proposal would be to close one lane at a time. The Council has received notification that the road closure will go ahead as proposed.

- iii. **Local highway Initiative – Build out on Frogge Street**
Highways have given a provisional start date of 4/3/2020. The work will take 3 days to complete under localised traffic management. The working hours will be 0730 – 1730 Monday – Friday. All being well the build out and lining should be completed before the weekend, but this is weather dependent.
- iv. **Grit bins – Icknield Close & Stackyards**
A resident of Stackyards has requested that the Parish Council consider purchasing grit bins. The grit bins can be purchased from Highways at a cost of £140 + VAT. Highways will fill the bins with grit. Cllr Wombwell proposed purchasing two bins and Cllr Gibson seconded. ACTION – Clerk to order the bins.
- 186/19-20 **Rural Crime Report**
The fly tipping at Gypsy Corner has now been cleared after several reports were made by the Parish Council.
Hare coursing continues to be problematic in the area.
Traffic along Grange Road continues to be busy. Of note is that a lamb was hit by a car near Grange Road and was not reported.
- 187/19-20 **Reports from County and District Councillors**
Report from District Cllr Peter McDonald (Appendix A)
The Parish Council spoke at length with District Councillor McDonald about planning delegations. Parish Councils previously had an automatic right of referral and since the change only 1 in 20 requests for applications to be referred to the District Council Planning Committee are granted. Planning officials effectively made the decisions and elected Members do not conduct site visits to assess applications. Further information on the changes to planning delegations should be provided by South Cambs District Council in due course.

 - i. **Planet Aid**
The clothing bank at the Village Hall car park produced 1,520 kg of donated clothing in 2019.
 - ii. **David Lilley - Annual gravestone check**
Mr Lilley conducted the annual gravestone check in the cemetery and church yard earlier in the month and reported that there is no significant deterioration to gravestones but that two trees in the cemetery may need removing in the near future.
 - iii. **Cambridgeshire Constabulary service change consultation**
Cambridgeshire Constabulary will be consulting the public on proposals to enhance their service for the south of Cambridgeshire. This will take place from Saturday 1st February to Saturday 29th February 2020. They have launched a consultation website – www.cambspoliceconsultation.co.uk – which includes a video, FAQs and more information about why they are making the proposal.  - iv. **Liaison meeting with acting Police and Crime Commissioner**
A meeting for Parish Council representatives with the acting Police and Crime Commissioner Ray Bisby will take place on 4/3/2020 at Abington Village Institute at 6pm. Noted.
 - v. **Projects supporting South Cambridgeshire to become zero carbon – Village Hall LED lighting**
The Parish Council were pleased that the application for a zero carbon community grant made by Ickleton Village Hall was successful and that they will receive £8,387.00 to fund LED lighting in the Village Hall.
 - vi. **Letters from Fews Lane Consortium Ltd and Sth Cambs District Council regarding Sth Cambs planning changes**
Further letters received this month regarding changes to planning delegations. The Parish Council discussed this at length in an earlier agenda item (187/19-20). It was noted that Fews Lane Consortium are taking SCDC to the High Court to challenge its conduct.
 - vii. **Planning application – Abbey Barns**

A letter to South Cambs District Council from Cowper Griffiths Architects was sent to the Parish Council regarding a planning application at Abbey Barns, Ickleton (S/4304/19/FL). The Architects noted the Parish Council's concern that a traffic plan was not submitted with the application but stated that the concern was misplaced as the proposal is compliant with planning policy, and that car numbers and parking spaces were skewed at present due to two contractors working on the site. Therefore, they felt that objection by the Parish Council should be discounted. The Parish Council will not withdraw its objection.

Updates on current applications

- i. **Marshall Aerospace and Defence Group**
The Imperial War Museum at Duxford has been removed from the shortlist of potential new sites for Marshall Aerospace and Defence Group.
- ii. **Wellcome Genome Campus**
The application was the subject of third party requests to call in for determination by the Secretary of State for Housing, Communities and Local Government. Ickleton and neighbouring Parish Councils submitted requests. The Secretary of State has decided not to call in this application. He is content that it should be determined by the local planning authority. South Cambs District Council are expected to hold informal discussions with Parish Councils.
- iii. **Uttlesford Local Plan**
The Inspectors letter to Uttlesford District Council following the stage 1 hearing sessions has been published. The Inspectors have recommended deleting North Uttlesford Garden Village in addition to starting again with the local plan. The Parish Council noted the Inspectors criticism of UDC's conduct during the consultation.
- iv. **Huawei**
Email received from the Head of UK Government Relations at Huawei informing the Parish Council that they expect to submit their revised application early in the new year and offered the Parish Council a briefing ahead of the submission regarding the changes they have made. The Parish Council will await the revised application without requesting a briefing. It was noted that Huawei own land on the other side of the A1301 to the current commercial premises and consideration was given to whether Huawei would submit an application for housing in the future on that land.

Greater Cambridge Local Plan

Cambridge City Council and South Cambridgeshire District Council are working on a new joint Local Plan that will affect the future of Greater Cambridge over the next 20 years. The Councils are carrying out a public consultation called: Greater Cambridge Local Plan – The First Conversation. The consultation will start the conversation about the kind of place we want Greater Cambridge to be in the future. It will explore the ‘big themes’ – climate change, biodiversity, social inclusion and great places - that will influence how homes, jobs and infrastructure are planned, and where growth might go. During the consultation there will be pop-up ‘roadshows’ to places around the area including shopping centres, schools, community centres and other places, to reach out to as many people as possible. There will also be a ‘Big Debate’ on the evening of 18/2/2020. The consultation will run between 9am Monday 13 January and 5pm Monday 24 February 2020 on www.greatercambridgeplanning.org.

192/19-20 Brookhampton Hall

Cllr Sadler wished to bring to the Councils attention the poor state of Brookhampton Hall. ACTION – Clerk to report to South Cambs District Council.

193/19-20 Reports from Councillors

Cllr Pavelin:

The Parish Council have been notified of the arrangements for the 2020 Cereals event and Cllr Pavelin requested that the Clerk make contact to ask what support the event organisers will offer to the local community. ACTION.

Cllr Sadler:

Reported that he responded to the Royston to Granta Park A505 study on behalf of the Parish Council. Only three Parish Councils responded so the deadline has been extended.

Has been advised by the Chairperson of Hinxton Parish Council that the ditches near to The Glebe are being cleared out this week. The Chairperson also requested that Ickleton Parish Council share information and advice on implementing a 20mph zone.

Asked if the Parish Council would like him to respond to the Greater Cambridge Local Plan Consultation. It was agreed he would do so on the Council’s behalf.

Cllr Wombwell:

Expressed her dissatisfaction in the way that Highways responded to the damage at the Imperial War Museum at Duxford during the recent bad weather and has sent correspondence to District Cllr Peter McDonald to that effect.

The bollards at the give way sign on Frogge Street are still missing. This has been reported to highways on several occasions and remains recorded as scheduled work.

Last month the Parish Council proposed that a programme to re-instate the grass verges in the village was commenced. Cllr Wombwell noted that two effected areas had been caused by building work and associated vehicles, and the Parish Council had received correspondence from a parishioner to that effect. The matter has been addressed with the relevant parties and the Parish Council will monitor the situation. She suggested that consideration is given to re-turfing the verges on Abbey Street rather than seeding.

It was noted that an invoice from Charles Frankau for the 2019 grass cutting season has not been received to date. ACTION – Clerk to request invoice.

ii. Clerk training – Rialtas £432.00

Year end accounts preparation with finance software company. Cllr Wombwell proposed that the training is undertaken, all other Councillors agreed.

- iii. **Cork boards for bus shelters**
Cllr Wombwell proposed that two new cork boards are purchased for the bus shelters. All other Councillors agreed in principle, Clerk to obtain prices and present to the Parish Council next month. ACTION.
- iv. **Quote for Chapel roof repairs**
Bob Calladine has provided a quote for materials and labour at a cost of £500.00 to repair the cemetery chapel roof. Cllr Wombwell proposed that the work is carried out, all other Councillors agreed.
- v. **Quote for verge posts**
Dominic pallet has provided a quote for materials and labour at a cost of £776.48 to install verge posts around the village green. Cllr Sadler proposed that the work is carried out, Cllr Wombwell seconded.
- vi. **Clothing bank income from the Salvation Army**
The distribution of income from the clothing bank was discussed and the Parish Council decided to see how much income is generated before deciding how it is distributed.
- vii. **Review of burial fees**
The Parish Council had a lengthy discussion about the burial fees. They looked at fees charged by two other South Cambs Parish Councils and the Church of England table of parochial fees from 1 January 2020. The Councillors views differed and a mid-way figure was decided by a majority vote.
The exclusive right of burial in earthen grave (99 years) and internments for adults will increase to £160.00.
It was decided that the age of an adult interment would increase to 18 years and above, and that interments of children aged 17 years and under would not be charged.
It was also decided that the foregoing fees will be trebled where the person to be interred or in respect of whom the right is granted is not, or was not immediately before his or her death, an inhabitant or parishioner of the Parish of Ickleton and that a line will be added to state that it will exclude persons subject to periods of absence in a care home, hospital or similar. ACTION – Clerk to amend document, circulate to funeral homes and upload to village website.
- 195/19-20 **Website accessibility regulations**
Last year the government introduced regulations with the introduction of measures to ensure that all public sector websites are accessible to all users, particularly those with disabilities. In light of this the Parish Council has decided to take the opportunity to create a new website. The Society of Local Council Clerks (SLCC) have secured an agreement with website developers Aubergine to offer website packages to Parish Councils at a cost from £700 + VAT. ACTION – Clerk to make further enquires with SLCC and with a local website designer known to the Parish Council. For further discussion next month.
- 196/19-20 **Review of risk assessment document**
The updated Risk assessment document was reviewed and approved by the Parish Council.
- 197/19-20 **Tree/hedge planting and verges**
The Parish Council obtained a quote from Practical Plants Ltd with a choice of hedging for the Village Green. It was decided that a further discussion on these matters should be had next month when more Councillors are present and so a second quote can be obtained.
- 198/19-20 **VE day commemoration and Operation London Bridge**
Operation London Bridge is a national protocol that Cambridgeshire will follow in the event of the death of the Sovereign. Cambridgeshire County Council has provided the Parish Council with a copy of the protocol.
The Parish Council are aware that The Ickleton Society will be commemorating VE Day on the 8th May 2020.

District Councillor Report for Parish Councils – February 2020

Local Council By-Election

Following Peter Topping's resignation, I decided to put myself forward for Cambs County Council in the Feb 27th by election. Given all that is going on with infrastructure and the impact of County decision on us, I felt it was the right thing to do. Naturally you will all make your own decisions on this.

South Cambs Business Support

I have been asked by the Leader to be Business Champion in South Cambs and Im pleased to report that a new team will be set up to increase support for local businesses – particularly small and medium-sized companies – in South Cambridgeshire.

At a meeting of the District Council's Cabinet last month members agreed to a proposal for a new Business Support Service. It will deliver activities offering practical advice and targeted support to existing and growing businesses in the District and those looking to move into South Cambridgeshire.

Councillors want to build thriving village economies where people can work locally, buy what they need and access the services they require while keeping their impact on the environment to a minimum. The new team will be tasked with retaining existing employers, improving the survival rates of new enterprises and securing new investment in communities across the district.

When fully established, the new team of four officers will:

- Offer bespoke packages of support to small and medium-sized enterprises
- Help further develop the three Enterprise Zones in South Cambridgeshire, to encourage more businesses to locate to them
- Guide companies wishing to relocate to the district or move within it
- Deliver a programme of activities to support local village economies
- Develop new and environmentally friendly tourism initiatives such as cycling and walking routes to encourage visitors into South Cambridgeshire communities
- Provide guidance to companies on their response to the climate emergency, including advice on generating their own electricity, improving energy efficiency and recycling more waste and water
- Make the entire Council more 'business friendly', such as by creating one point of contact for local companies and becoming a vital link between the Council and other business support organisations

Growing local businesses and economies is one of the four priority areas in the Council's Business Plan and this new team, working closely with colleagues at the Greater Cambridge Shared Planning Service, will lead the authority's work in this area.

The new roles and Business Support Service will now be finalised before recruitment takes place within the coming months. When up and running, the service will work closely with neighbouring councils, and organisations such as the Chambers of Commerce, FSB, NFU and Visit Cambridge and Beyond to help complement the services that each provides.

Planning

Officers have arranged four workshops for all parish councils to attend to learn how they can access planning applications in our new planning software (Uniform-Idox). Three have been held to date and, as per our reminder on Monday, the final one is being held on Wednesday 5th February from 6pm to 8pm at the Chamber.

This is very important for the changeover to the new software which will happen in two weeks' time. It is important that parish clerks know how to access the new planning portal and the plans that will be uploaded to it.

Greater Cambridge Local Plan

As I mentioned in my December report it is a very exciting time jointly for Cambridge City and South Cambridgeshire District Councils, with work underway on a new joint Local Plan that will affect the future of Greater Cambridge over the next 20 years.

The Councils are preparing to carry out a public consultation called: Greater Cambridge Local Plan – The First Conversation. The consultation will start the conversation about the kind of place we want Greater Cambridge to be in the future. It will explore the 'big themes' – climate change, biodiversity, social inclusion and great places - that will influence how homes, jobs and infrastructure are planned, and where growth might go.

The consultation began on Monday 13 January and will run until 5pm Monday 24 February 2020. Lots of information and the opportunity to provide views at www.greatercambridgeplanning.org People can also post online using #GCLocalPlan.

During the consultation there will be pop-up 'roadshows' to places around the area including shopping centres, schools, community centres and other places, to reach out to as many people as possible.

There will also be a 'Big Debate' on the evening of 18 February, where we are inviting local groups to share their ideas about what should be in the Local Plan, in a fun, provocative and lively public event. Cambridge Police station move consultation

In February, Cambridgeshire Constabulary will be consulting the public on a proposal to "replace our outdated facilities at Parkside with both a new city centre police station and a police hub on the outskirts of Cambridge." The consultation site claims that "together these [changes] will meet the county's growth and respond to the challenges of modern-day policing."

The consultation will take place from Saturday 1st February to Saturday 29th February 2020. Posters and information leaflets will be distributed to libraries and police stations across the county. The proposals include keeping a police station (though not custody cells) in the City.

Zero Carbon Community Grants

Over £120,000 was handed out by South Cambs District Council in the end. The grant pot was increased because the council wanted to support all the brilliant ideas that met their criteria. Villages went for electric bikes, tree planting, Eco-Eats festival, repair cafe and other ideas – the full list is available on <https://scambs.moderngov.co.uk/ieDecisionDetails.aspx?ID=11231> , including those that did not receive funding this time. Ickleton was successful in its energy efficient application for £8,387.

South Cambs District Council budget setting

As I mentioned in December the South Cambs element of Council Tax will go up in April by £5 for each Band D property (the amount that the Government has set as a cap for authorities with a low current council tax). There are expected to be difficult decisions to be made next year, when SCDC will get less from the increase in Business Rates, due to the expected 'Fair Funding Review' which has been delayed by a few years.

Making South Cambs Offices Greener:

Proposals have been put forward to make the Council offices less dependent on fossil fuels, including installing a solar car port which will generate more than 20% of the electricity for the entire building and installing a ground source heat pump to reduce the amount of gas used on site by at least 80%. The funding for the works would come from the Council's 'Renewables Reserve' that derives from Business Rates that are paid by renewable energy sites in the district and earmarked for investment in energy efficiency projects. This fund also pays for local, community projects to reduce carbon emissions through the Council's Zero Carbon Communities grant scheme.

East West Rail Route Confirmed

The route for East West Rail has been announced by the Government. Transport Secretary, Grant Shapps, made the announcement last week that route E had been selected for the railway line linking Cambridge and Oxford. The route via Cambourne was the option South Cambridgeshire District Council said should be chosen when asked during a consultation. Alternatives through the district were via Bassingbourn. The decision on whether this will be an electrified line has not yet been made but we are told that it will be a net zero carbon railway which is exactly what we would want as we move towards being a zero carbon district by 2050.

Disabled Facilities Grant

A survey of all houses across the district has been carried out to look at properties which are fuel inefficient. A database has now been created and letters sent out to 250 dwellings across South Cambs with an Energy Performance Certificate rating of G - the lowest band. Last year, the rules on the allocation of this grant were extended so that homes which were poorly insulated or indeed with inefficient heating systems could be upgraded. There has been an underspend of this budget at South Cambs over the past few years, meaning that once key repairs and housing adaptations - such as fitting a wet room - had been carried out almost £200,000 has been carried over to date.

The grant is means tested and there is a cap of £10,000 per household so the Council will wait to see what the uptake is and then extend it to properties rated as an F on an energy performance certificate.

Alongside this, the council is also putting out to tender a service to provide energy efficiency advice. Owner occupiers and tenants in council or privately rented properties will all be able to have a free assessment and receive advice on how to obtain grants or receive discounts towards energy saving improvements. More information to follow once a company has been selected.

In addition to the online portal GCSPS have set up a Shared Complaints Mailbox (Complaints&Compliments@greatercambridgeplanning.org). Any complaint queries or updates should be placed through the portal as this will be the quickest way to establish contact with their investigator. There may be instances where you want an update on a specific case and you can request this via email to the shared mailbox. Currently, emails are being sent directly to individuals across planning which has delayed our awareness of some complaints. This change addresses this issue and will allow queries to be answered much quicker.

Royston to Granta Park aka A505 Study

Wellcome Genome Campus (AgriTech):

Hinxton and other Parishes submitted to SoS to call in the decision on basis of landscape and inconsistencies with AgriTech. We have been informed the SoS will not decide until March 30th.

Huawei
