**177/22-23 To Receive Apologies for Absence**

**179/22-23 Open Forum for Public Participation Including Youth Representation**

John O'Toole and Ray Hackett attended the meeting to speak about Coploe Pit. Both have attended the pit on previous occasions on an informal basis to undertake work with the Cambridge Conservation Volunteers. They would like to make a formal arrangement with the Parish Council to act as wardens. They will provide a management plan and risk assessment.

**180/22-23 To approve minutes of meeting held on 15<sup>th</sup> February 2023**

It was resolved that the minutes of the meeting held on 15<sup>th</sup> February 2023 are approved and signed by the Chair.

**181/22-23 Matters Arising/Clerk's report**

**i. Clerks report**

**EV charging points:**

The Clerk attended an online EV charging point event hosted by Cambs ACRE and led by Luke Waddington from South Cambridgeshire District Council's Climate and Environment team. Of relevance to the Parish Council is the On Street Residential Charge Point Scheme. The County Council would bid for funding from the Government and then the Parish Council would bid for a charging point to be installed in Ickleton. To be discussed with Cllr Peter McDonald.

**Cemetery and chapel:**

A review of burial plots puts the number of plots available at approximately 17. Cemetery expansion to be added to the April 2023 agenda for further discussion.

The bat survey and woodworm treatment at the cemetery chapel is outstanding. In addition, damage has been caused to the roof and brick work.

ACTION – Clerk and Councillors to find a tradesman to complete repair works.

ACTION - Cllr Pavelin to put up new cemetery sign.

**Commemorative trees:**

Two ornamental pear trees and an oak tree have been planted on the recreation field. The oak tree was supplied by the South Cambs District Council 'six free trees scheme' so the amount agreed for the purchase of an oak was reallocated to purchasing the ornamental pear trees.

ACTION – Clerk to add the oak tree in commemoration of Queen Elizabeth II to the Queens Green Canopy map.

**ii. South Cambs District Council – Delivery of magazine**

Smart Distribution have not been delivering the South Cambs Magazine to Ickleton as per their contract with SCDC. They were directed to redeliver the Winter edition to the Parish in early January 2023. The Spring edition is due at the end of February/beginning of March 2023. A copy will be delivered by Smart Distribution and a second copy will be posted. Therefore, Parishioners should receive the next edition. SCDC are considering the best way forward for future editions and have asked if any Parishioners would like to act as a delivery agent employed by Smart Distribution to deliver the magazines as part of the SCDC contract. The possibility of incorporating delivery of the SCDC magazine with Icene was considered but the delivery dates were not compatible.

Councillors confirmed that the Spring edition has not been delivered. ACTION – Clerk to notify SCDC.

**182/22-23 Defibrillator check**

The defibrillator was checked on 13/3/2023. The infant pads have been replaced. A new cabinet was installed on 13/3/2023.

**183/22-23 Traffic and Highways Issues**

**i. Speedwatch**

Reduced sessions have been held over the last few weeks due to the cold weather. Cllr Sadler wished to remind Councillors that speedwatch was set up in order to evidence parish support for traffic calming initiatives.

**184/22-23 Rural Crime Report**

Fly tipping on Grange Road was reported to Environmental Health (EH) last month. EH Officers attended six weeks later but the waste had already been removed by unknown persons.

Bollards on the verge outside the entrance to Caldrees Manor on Abbey Street appear to have been hit by a vehicle. ACTION – Clerk to report to Highways.

**i. Cambs Home Improvement Agency – service information**

Cambs Home Improvement Agency is a not-for-profit shared service for South Cambs. They provide advice, support and assistance to the elderly, people with disabilities and vulnerable people to help them repair, improve, maintain and adapt their homes to meet their changing needs. The purpose of the service is to help people remain independent, warm, safe and secure in their own homes. They undertake a wide range of activities ranging from stairlifts, level access showers and ramps to heating systems, guttering and electrical safety related works. The majority of Councillors wanted to note this application and not pass comment. There was a general feeling that the landscaping around the A1301 was an improvement upon the original plans that had been given outline permission. The removal of three pedestrian/cycle crossings at roadway level and provision of two bridges over the A1301 for pedestrians and cyclists was seen as less of an impediment to road traffic than the original concept.

The Parish Council did not receive formal notification of this application. ACTION – Clerk to contact planning to request notification of all the Wellcome development planning applications.

**Cllr Cheney:**

Parishioners have reported that the train crossing lights on Mill Lane are noticeably bright.

Another Councillor noted that the time between the lights activating and a train passing is very quick. ACTION – Clerk to contact Network Rail about the matters.

Pot holes in and around the village were repaired last month. The standard of repair appears to be poor and the holes have re-appeared. ACTION – Clerk to report to Highways.

The defibrillator cabinet is covered with the insurance under standard cover.

**v. Burial fee review**

Cllr Sadler proposed, Cllr Davidson seconded and it was resolved to increase the burial fees as follows:

Exclusive right of burial in earthen grave (99 years) - increase to £200.00

Interments Adults (18 years and over) - increase to £200.00 Children (17 years and under) - remain no charge

Interment of cremated ashes in a grave space of another interred member of the family to which exclusive right of burial has been granted - increase to £80.00

For the right to erect a Headstone not exceeding 3 feet in height - increase to £100.00

For the right to erect kerbing in line with Memorial conditions - increase to £100.00

For the right to erect a monument in the form of a vase not exceeding 12 inches in height - increase to £80.00

For the right to erect an additional memorial plaque eg to denote the interment of ashes - increase to £80.00

Any inscription after the first - increase to £80.00

**vi. Purchase of defibrillator cabinet**

The Clerk exercised the power to authorise expenditure on behalf of the Parish Council of up to £500 in cases of extreme risk to the delivery of council services by ordering a new defibrillator cabinet at a cost of £500 +VAT. The Chair and others Councillors were notified and agreed to the expenditure by email correspondence.

**vii. Purchase plastic verge posts**

Following on from a discussion at the January 2023 Parish Council meeting, Councillors resolved at the February 2023 Parish Council meeting to purchase number of plastic bollards for various locations in the Parish. The Clerk sourced prices from various different suppliers. Cllr Sadler proposed, Cllr Heaney Seconded and it was resolved to purchase 20 bollards at a cost of £535.00 +VAT.

**viii. Cam Valley Forum Membership**

Cllr Sian Wombwell proposed, Cllr Sadler seconded and it was resolved to pay the £10.00 annual subscription fee to Cam Valley Forum.

**Appendix A**

**Report for Parish Councils – March 2023.**

**South Cambs District Council**

**Further £200,000 proposed for cost of living support**

Plans for a further cost of living support package for residents, worth more than £200,000, have been published by South Cambridgeshire District Council. The proposals include a roadshow of cost of living talks, support to transform some Warm Hubs into Community Wellbeing Hubs, increasing awareness of Council Tax support, more free energy saving appliances and the creation of a South Cambridgeshire Sustainable Food Network. The plans will be presented to Cabinet on 20 March.

The proposals build on a package of almost £400,000 of support agreed by the Council in November. Just over half of that initial funding came from the Cambridgeshire and Peterborough Integrated Care System (ICS) to support community-based programmes.

The new plans set out the Council's next steps for cost-of-living support. The ICS have indicated that they will provide further grant funding that the Council will bid for, to continue projects for the next financial year. These will continue to focus on prevention of poor health resulting from financial hardship and living in cold homes.

**Housing plans for 2023/24**

The Council's Housing Revenue Account is ring-fenced and used to maintain its stock of around 5,600 Council homes. Plans for housing include:

- Having doubled the number of new Council homes built from 35 in 2019/20 to 70 in 2021/22, the new target is for at least 75 new energy-efficient Council homes to be delivered every year.
- During the next two years, more than £2 million has been allocated to continue to upgrade existing housing stock, as part of continuing carbon reduction efforts.

**Asylum Seekers Hotel Housing**

The Home Office has informed local councils that they are now using the Cambridge Bar Hill Hotel as accommodation for asylum seekers. This is part of a national programme throughout the UK to deal with an increase in the number of people arriving in the UK and the decision by the Home Office to 'disperse' asylum seekers across the country.

The hotel, which has 136 rooms, will be used to house a maximum of 272 people who have arrived in England after crossing the Channel by boat. The Home Office has informed the Councils that the new arrivals will be families and

single females. However, the people who stay in the hotel is determined by needs and pressures within the asylum system and is a Home Office decision.

If the hotel is used for mainly families, the number of people at the hotel will be less than the maximum capacity. The hotel will not be open to other guests for overnight accommodation.

South Cambridgeshire District Council, Cambridgeshire County Council and the Cambridgeshire & Peterborough Integrated Care System are now working together to provide support, including:

- Applying for school places
- Ensuring appropriate healthcare is available
- Keeping the local community informed of the Home Office's plans
- Considering the social needs of asylum seekers and working with the voluntary sector, Bar Hill Parish Council and other groups to address these where possible

Those staying at the hotel will remain there as asylum claims are assessed. During that time, the Home Office will provide them with three meals a day, toiletries, a laundry service and £9.10 per week.

The day to day arrangements at the hotel in Bar Hill will be overseen by Serco, who are working with the Home Office to deliver the asylum accommodation scheme. There will be security provided at the hotel for 24 hours a day, seven days a week.

Children who arrive at the hotel in Bar Hill will be given access to education, as anyone arriving in the area would be. This could be through attendance at local schools and colleges. Asylum seekers will apply for school places for their children in the same way as all other residents. Support will be provided.

Asylum seekers will also be able to access local health services in the same way that any person visiting South Cambridgeshire on a temporary basis would. Health partners are working on the best way to accommodate this locally, whilst considering and being conscious of existing demand for local services.

Following their time at the hotel, the asylum seekers will be moved to other temporary dispersal accommodation provided by the Home Office as it becomes available. This could be anywhere in the country. This future accommodation will not be provided by local Councils.

## **Cambridgeshire County Report**

### **Secondary School Places**

The number of pupils offered a place at one of their preferred Cambridgeshire secondary schools has risen. In total, 6459 pupils have been allocated a place at their first-choice secondary school for September 2023, compared to 6285 last year.

This represents 87 per cent, compared to 90 per cent last year – but the total number of places allocated has increased from 6983 last year to 7413 this year. The percentage of pupils offered a place at their second or third choice school has also risen – from 7.2 per cent (501 pupils) in 2022 to 8 per cent (619 pupils) in 2023. Year 6 students will hear 1st March which secondary school has offered them a place for September 2023.
