## 108/22-23 Open Forum for Public Participation Including Youth Representation

The two Parishioners present stated that they had attended the Great Chesterford Parish Council meeting last week and heard that work on the overgrown vegetation and pot holes near to the Ickleton to Great Chesterford railway crossing should be carried out in January 2023.

They stated that drone footage of the Boro Farm Aggregate site had been taken by Great Chesterford Parish Council showing the scale of the site and activity. Essex Planning Enforcement have recently issued a Temporary Stop Notice at the site. The Parishioners have witnessed breaches which they have reported to the Planning Enforcement Officer who has said that failure to comply with the requirements of a notice is an offence and a matter for Essex County Council and not the Police. They went on to say that whilst the aim of the criminal process is to punish wrongdoing, the County Councils decision to prosecute as part of enforcement action is not to penalise but to prevent further harm. The Parishioners will distribute flyers through the Parish to encourage other Parishioners to submit comments to the Appeal.

It was noted that the Walden Local newspaper recently featured an article about the site.

## 109/22-23 To approve minutes of meeting held on 19<sup>th</sup> October 2022

It was resolved that the minutes of the meeting held on 19<sup>th</sup> October 2022 are approved and signed by the Chair.

#### 110/22-23 Matters Arising/Clerks report

Cllr Peter McDonald was going to contact the Highways Project Team Manager about the Privately Funded Local Highways Initiative but hadn't provided an update and wasn't present at the meeting. ACTION – Clerk to request an update.

Roundels and public footpath signs are still to be put up in Back Lane. The condition of Back Lane appears to be reasonable at this time.

### 111/22-23 Defibrillator check

Defibrillator check carried out by the Clerk on 16/11/2022.

The Clerk was notified that the East of England Ambulance Service had recorded that the defibrillator had been requested for use on the 5<sup>th</sup> of November 2022. The defibrillator was checked and had not been used.

#### 112/22-23 Traffic and Highways Issues

# i. Speedwatch

No update from the Speedwatch Team, but Councillors have seen sessions being carried out.

# ii. Local Highways Initiative 2023/24

The Parish Council will consider submitting previous unsuccessful applications. New applications relating to an HGV weight limit and improvements to the footway connecting Ickleton to Great Chesterford will also be considered. The latter is likely to be costly, but the Council could consider a feasibility study for the project to be funded by the Local Highways Initiative 2023/24. Cllr McDonald stated at the last meeting that Network Rail are making improvements to Whittlesford

Station and suggested the Parish Council make enquiries. ACTION – to carry over to the December 2022 Parish Council meeting for further consideration and a decision.

# iii. Cambridgeshire County Council Highways - Bridge defect, Junction of Grange Road/Coploe Road/ Duxford Road

The culvert at the junction of Grange Road/Coploe Road/Duxford Road was reported to Highways in April 2021. The Parish Council have been informed that as part of Cambridgeshire Highways planned maintenance programme, they will be carrying out work to address this issue this financial year. At this stage they cannot provide any further timescales or specific dates for this work to be carried out. Noted by the Parish Council.

## 113/22-23 Rural Crime Report

Several incidents of crime have occurred in and around the Parish. Four picnic tables were stolen from the pub car park in the early hours of the morning, a truck was stolen from a driveway in The Stackyards, diesel was stolen from diggers in Hinxton and horse boxes and equipment were stolen from a livery in the area.

# iv. Review Village Hall blood session donations

At the November 2021 meeting the Parish Council resolved to donate £100.00 to Ickleton Village Hall for blood donation sessions for a maximum of four times a year and to be reviewed annually.

Councillors had a lengthy discussion taking into consideration the Parish Council finances, Village Hall finances and donations recently made to the Village Hall by the Parish Council. Cllr Pavelin proposed that the Parish Council continues to donate £100 four times a year. His proposal was not seconded and therefore the arrangement will not continue.

# v. Various quotes for maintenance work on the recreation field and play area

This will be carried over to the December 2022 Parish Council meeting as the necessary information had not been obtained in time for the meeting.

# vi. Request for funding from Ickleton Cricket Club

The Cricket Club would like to install boundary netting in order to protect a neighbouring property. The project will cost around £5,000. The occupants of the neighbouring property have offered to make a contribution to the cost. The Cricket Club has made an application for a Community Chest Grant and have been told that if the initiative is on Parish Council land, a 50 percent contribution from the Parish Council is expected. Therefore, the Cricket Club have asked for a contribution of £1,000 from the Parish Council.

After a lengthy discussion Cllr Hamilton proposed, Cllr Heaney seconded and it was resolved that the Parish Council would make the contribution of £1,000.

## 121/22-23 Recreation Field and Play Area

#### i. Cricket club – relocation of basketball court

The location of the court is currently within the normal boundary of the cricket pitch and the club would like to organise the moving of the court to a position that doesn't impact on the playing area. Members of the Cricket Club and Parish Council met to consider a relocation site next to the skate ramp, at a slightly reduced size and to have the hoop repositioned. Basketball court installers have said the current size is non-specific and users will not suffer from a small reduction in size. It would require the removal of one oak tree.

The Parish Council agreed in principle to the relocation site, but question whether there is a need for an oak tree to be removed and note that this will be a cost incurred by the Parish Council.

## i. Memorial checks

The Clerk asked Councillors to consider appropriate training to be carried out by those responsible for conducting memorial checks. It was resolved that the current arrangements will continue and the Clerk will check with Funeral Directors and Stonemasons that memorials comply with BS8415.

## Report for Parish Councils - November 2022.

### **South Cambs District Council**

#### **Warm Hubs**

The first Warm Hubs have opened their doors as part of a new initiative to support communities in South and East Cambridgeshire this winter.

Warm hub accreditation In South Cambridgeshire, the first Warm Hubs have opened at Gamlingay and Caldecote.

Hardwick, Cottenham and Comberton will be the next villages to see Warm Hubs open their doors.

East Cambridgeshire Warms Hubs are at Haddenham, Soham and Little Thetford. Hubs at Ely, Burwell and Stetchworth will shortly follow suit.

More hubs will open in November across both districts. Operated from community buildings across East and South Cambridgeshire, Warm Hubs are designed to support vulnerable and isolated people, as well as those on lower incomes; at a time when the cost of living is a significant challenge.

The new initiative has been developed by South and East Cambridgeshire District Councils and funded by NHS Cambridgeshire & Peterborough, part of our local Integrated Care System.

As an affiliated network, the Warm Hubs are coordinated by Cambridgeshire ACRE – the charity dedicated to supporting and strengthening rural communities across Cambridgeshire.

#### **Councillor Award**

# **Supermarket Vouchers**

Over 21,000 families received supermarket vouchers last half term in a bid from Cambridgeshire County Council to help tackle financial pressures during the school half term break.

The cost-of-living crisis, and rising energy bills have put an additional strain on families who were already worrying about how to make ends meet. The County Council distributed over £320,000 from the Holiday Voucher Scheme to

provide support during the October half term. The scheme will also continue in December and February half terms, to give families a helping hand during the winter.

21,427 vouchers were sent to support children who would usually be eligible for other support. Each eligible child's parent was issued a £15 voucher that could be used at a supermarket of their choice. Eligibility automatically included families who met the following criteria:

- Early Years Pupil Premium
- Children eligible for income related funded two-year-old education
- Eligible for income-related Free School Meals
- Students eligible for 16+ bursary.

# Foster Carers Unaccompanied Children

An appeal has been launched to find more Foster Carers for unaccompanied children who are seeking asylum in Cambridgeshire and Peterborough.

The Cambridgeshire and Peterborough Fostering Service urgently needs carers to meet the needs of children and young people who are often forced to leave their family and country behind to seek protection from violence, persecution, war, detention, climate change, terrorism, or the disappearance of their family. When unaccompanied minors arrive in the UK, they're looked after by the local authority who will safeguard them and promote their welfare. They frequently take long and dangerous journeys alone, or are trafficked in circumstances unknown to them, arriving at their destination feeling confused, alone, and disorientated.

Unaccompanied minors are also likely to have different cultural, religious, family and language experiences. Foster Carers support unaccompanied minors to maintain their cultural and religious identity while helping them integrate into a community in Cambridgeshire or Peterborough.

By becoming a part of the Local Authority's Fostering Community, you can help us to guide vulnerable children and young people through their early years and play a central role in supporting children and young people to heal, and develop into happy, healthy adults who have a bright future.
